## **Step 4: Processing of Police Clearance**

- Proceed to your selected Police Station on your date of appointment. Present the following to the Police Station:
  - ✓ One (1) valid Government issued ID;
  - Proof of payment/Payment Confirmation;
  - ✓ Reference Number of NPC Appointment;
- ✓ Have Biometrics, Picture and Signature taken;
- ✓ Wait for your name to be called for the verification process or release of National Police Clearance.







## NOTES:

- 1. For FIRST TIME JOB SEEKER applicants (RA 11261), secure a copy of FTJS Certification certifying that you are a First Time Job Seeker and present it to the Police Station together with your one Valid ID. Free Clearance for FTJS can only be availed once.
- 2. For first time applicants, personal appearance is required to have photo, electronic signature, and biometrics taken.





#### 3. For RENEWAL Process:

- ✓ Applicant must use / log- In the existing NPC Account.
   From their last application.
- Applicant can choose the renewal application if With or without appearance.
- ✓ For Non-Appearance. The applicant will be required to update the profile and upload 2x2 picture and selfie holding a valid government issued ID.
- ✓ Applicants need not to appear at the Police Station. Wait for the application to be processed and Clearance can be downloaded on their NPC Account Profile.





#### 4. Clearance Certification:

- Clearance Certification is intended only for the following first time applicants:
  - Filipino Citizen Working/Based in Other Country
  - Bedridden
  - -Petitioner (Applying for Probation/Bail)
